AFFIDAVIT

STATE OF OKLAHOMA - TRIBAL COURT OF CHOCTAW NATION: SS.

The undersigned upon oath deposed and states as follows, to wit:

ISSUANCE OF ARREST WARRANT- C.N.C.C § 1107- Sexual Battery

On 03/12/2025 I, Investigator Alena Brant spoke with Victim 1 at Public safety in Durant. Victim 1 advised on 3/7/2025 Victim 1 went into Ron (Ronald) Perry office to get water. Victim 1 got on the scale to check her weight. When she stepped down Ron came up behind her and asked her how much she weighed. Ron then picked her up as she was trying to walk out the door. Victim 1 told him to put her down. Victim 1 stated "he full on grabbed my butt - he had a handful. Victim 1 told him "Don't do that" and smacked his arm away.

On 3/18/2025 I spoke with Victim 2. Victim 2 said that she can't remember the date, but she had worn a dress to work. She remembers it was a black dress. She was in her office and Ron came in. Victim 2 remembers it was on a Wednesday because they were having their lunch. When Victim 2 went to leave her office Ron tried to lift up her dress and she punched him in the belly and told him "Don't do that", Ron laughed. The same day they were in the kitchen area. Ron tried pulling up her dress again.

On 3/18/2025 I spoke with Victim 3. Victim 3 was working job for the day, and it was around Christmas time in 2023. She had her back to the door and Ron came in. V. 3 was on the phone. While on the phone Ron put his hand down her shirt into her bra. V. 3 said that it shook her, and she did not know what to do. She moved away, since she was on the phone she mouthed stop to Ron. V. 3 said this year (Feb 2025) when she started working her current job Ron came up behind her and put his hand down her shirt. V. 3 talks about a day she was wearing leggings that had a print down the side. Ron ran his fingers up the print on her thigh. V. 3 said that she has seen Ron do and say things to Victim 4.

On 3/18/2025 I spoke with Victim 4. V4 said that it started about a year ago. V. 4 stated that she felt like, he felt he could touch her because she was single and didn't have a husband to go home and tell. One day she was on the phone in her office. Ron came in and stuck his hand down her shirt under the bra. V. 4 couldn't say anything because she was speaking to a guest on the phone.

V.4 said Ron had "did that" 3-4 times, putting his hand down her shirt. Ron would grab her behind when she was trying to fix his computer. V.4 said she had worn a dress to work, and Ron tried sticking his hand up her dress. She no longer wears dresses to work. At the 2024 Trunk or Treat in Stigler. Ron walks up behind her and grabs her be 3-4 times grabbing her butt and 3-4 times sticking his hand down her shirt, 2 times inside her bra.

On 3/19/2025 I spoke with Victim 5. She has been in the Stigler community center for three (3). V.5 said that it has been every single day. Ron comes into her office 4-6 times a day grabbing on her. V.5 said at first, she would be passing by, and he would slap or squeeze her butt. V.5 said that it's not just touching but it's verbally, asking for pictures, and talking about her body. Ron would also come up behind her and tries to get in her shirt. The first Wednesday she worked, everyone was already serving, and the hallway light was off, and he came into her office. She got up to walk out of her office. Ron came up to her, Ron took his fingers and ran his fingers up her front (vaginal area). She started working Wednesday two months ago. Ron would use his fingers to go up the crack of her butt. Ron calls it his daily feel. I asked V.5 about Ron trying to put his hand down her shirt and if he was successful in doing so, V.5 said yes. V.5 said it was under the bra when Ron put his hand down her shirt 2-3 weeks ago was the last time. In the three years time V.5 said that it has been 3-4 times that Ron has touched her boob under the bra. Hand far down that it touched her nipple. V.5 said it happens to her everyday she has to work with Ron.

On 3/19/2025 I spoke with Victim 6. I asked V.6 to tell me what had occurred. V.6 said that three years into her working at the Spiro Community Center Ron Perry would grab at her bottom. V.6 was working Job for the day the last time it occurred at the Stigler community Center. She thinks it was either Thursday or Friday. The date show was March 13th and 14th, 2025. Ron grabbed her butt. V.6 told him to stop. V.6 said that no one was around when it occurred.

On 3/28/2025 I, Investigator Alena Brant and Lt. Tony Krebs met with Ron Perry at the Choctaw Nation Community Center in McAlester, advised Ron that there had been some accusations that came up and an incident at the Stigler Community Center. I wanted to know his side of what occurred. Ron was asked about incident Victim 1. Victim 1 was standing in the door, and he needed to go up front to talk to someone. Ron stated, "I just jabbed her ass". I asked Ron what that looked like and to explain it to me. Ron put his hand in the thumbs up position and moved his hand upwards demonstrating how he "jabbed her ass". The worker told him Ron, I can't believe you did that, Ron stated "it looked so tempting, I couldn't resist".

I asked Ron if there were any incidents where he tried lifting up someone dress. Ron said no but then stated, V.2 but I was joking with her. I asked Ron if he has ever put his hand down any employee shirt into their bra. Ron stated, "well yeah". Ron said that she is short money, and he will slip her a \$100 dollar bill. I asked down her shirt and Ron said yeah. He advised that was victim 4. I asked Ron if it was into the bra, down the shirt or something else. Ron said into the bra where they always keep their money, I guess. I asked if he has done that to anyone else. Ron said not that he can remember. I asked if he has grabbed V.4 butt or anyone else's butt in the office, he said he might ve jokingly to push them out of the way. I asked Ron about V.5 and if he went into her office and touched her whether it was jokingly, inappropriately, or anything else. Ron said that he probably has.

I asked Ron if he has ever touched V. 5 breast area, Ron said "oh yeah". I asked Ron if that has been more than one time, he said "probably so". I asked if he remembered the last time he did that. Ron said she told him that she had a boyfriend and not to do that and he hasn't since. I asked if he remembered the last time, he said 2-3 weeks ago.

I asked Ron again that he would touch the girls butt but can't remember who, Ron said yeah. Ron advised that he thought after he did it, he shouldn't have. I asked Ron if he remembers touching V. 4 butt during the trunk or treat last year (2024), Ron said yeah. I asked him to tell me what that looked like. Ron said that she was dressed up. Ron said he snuck up

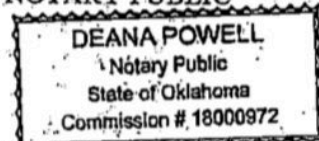

CHOCTAW NATION OF OKLAHOMA:

I, D. Michael Haggerty, II, the undersigned Tribal Prosecutor, in the name and by the authority of the Choctaw Nation of Oklahoma, give information that within this Tribal Court, **RONALD C PERRY**, the Defendant, herein, who is an adult Indian male, did then there unlawfully, knowingly, and wrongfully commit the crime(s) of:

COUNT 1: SEXUAL BATTERY ~ a FELONY, on or between the 1st day of January, 2024, and the 18th day of March, 2025, by knowingly and intentionally touching, mauling or feeling the buttocks and breasts of Victim 4, who is at least 16 years of age or older, in a lewd and lascivious manner.

This crime is punishable by imprisonment for up to 3 years and/or a fine of up to \$5,000.00.

COUNT 2: SEXUAL BATTERY ~ a FELONY, on or between the 1st day of January, 2025, and the 18th day of March, 2025, by knowingly and intentionally touching, mauling or feeling the genitals and breasts of Victim 5, who is at least 16 years of age or older, in a lewd and lascivious manner.

This crime is punishable by imprisonment for up to 3 years and/or a fine of up to \$5,000.00.

COUNT 3: SEXUAL BATTERY ~ a FELONY, on or between the 13th day of March, 2025, and the 14th day of March, 2025, by knowingly and intentionally touching, mauling or feeling the buttocks of Victim 6, who is at least 16 years of age or older, in a lewd and lascivious manner, 1121.

This crime is punishable by imprisonment for up to 3 years and/or a fine of up to \$5,000.00.

**MOTION TO MODIFY ORDER SEALING
COURT FILE FROM PUBLIC ACCESS**

COMES NOW the Choctaw Nation of Oklahoma, by and through the Tribal Prosecutor, and moves this Court to modify the order sealing the court file in this matter. In support of its Motion, the Nation would show the Court as follows:

1. These charges involve six different counts of Sexual Battery, in violation of Choctaw Nation Criminal Code § 1121, each count involving a separate victim. At the time these offenses were committed, the Defendant was a tribal councilman for the Nation, and each of the victims worked in the Stigler Community Center, along with the Defendant. Defendant has since [REDACTED] and it is believed that was due to these charges.
2. Based on information received by the Nation regarding threats made by various persons against the victims in this matter, on April 3, 2025, the Court ordered that access to the records of this Court be sealed from public access. Since that time, the victims' identities have apparently been disclosed by third parties.
3. On April 30, 2025, counsel for the Nation met with each of the victims in this matter. Each victim expressed their desire to have the court records in this matter be made

publicly available, subject to the requirements of Administrative Order AO-22-8, which prohibits publication of the actual court records online. However, the victims also wish for the Court's protective order to remain in place, prohibiting disclosure of any matter not in the public court record to any third person.

4. Under these unique circumstances, it is in the best interests of justice for the Court to order that the Order filed April 3, 2025 be modified as follows:

- 1) The Order shall be modified to permit the Court file in this matter to be publicly available, subject to the terms of Administrative Order AO-22-8.
- 2) The Order shall remain in full force and effect with regards to the contents of any law enforcement reports, results of any investigations, other discovery exchanged by the parties, or any other information not contained in the public court record. The parties are hereby prohibited from distributing those records or any information contained therein to any other person not a party to this action, or employed by counsel for the parties to this action.

5. Defendant has no objection to the relief requested herein.

WHEREFORE, premises considered, the Nation requests that the Court enter an order granting the relief requested herein.
